We especially seek nominations of members who demonstrate and represent leadership in the industry, possess the ability to think strategically, and are dedicated to RAiNA's mission and purpose. Specific responsibilities include oversight of RAiNA's strategic direction and fiduciary responsibility.

A person cannot nominate themselves, however, each nomination must be made by a member in good standing and the nomination cannot consist of more than one individual per Member Company.

The RAiNA office requires a nomination form, signed by the nominator along with three (3) additional nominators, RAiNA members in good standing.

A very important process to follow: If you are nominating another professional, please check with the person to ensure that they are willing to run, and are willing to provide the information requested in this form along with a bio and photo.

RAiNA values and seeks leadership representing diversity in features such as race, ethnicity, gender, age, sexual orientation, nationality, ability, geographic location, and type of professional experience.

Note: Being nominated does not guarantee a position on the Board. In addition, the election of candidates for the Board by the membership will take place to confirm all positions.
